In phase one, the Noida International Airport will have one terminal and will operate with one runway, 10 aerobridges and 25 parking stands. In this phase, the airport will operate 65 flights every day-62 domestic, two international and one cargo flight. 

Three months ago, my car an accident and was deemed a "total loss" by the insurance company. Two months ago, they offered me a compensation of Dh20,000, but I have not yet received the payment. Given this delay, can I claim additional compensation?

In response to your placed if it is deemed a total loss, unless a request is made by the insured to receive the equivalent amount in cash. In this case, the insured's request should be taken into consideration by the company. This is in accordance with the Chapter Two, Article 2 (c) of the Unified Motor Vehicle Insurance

Damage issued pursuant to the Regulation of Unified Motor Vehicle Insurance Policies according to Insurance Authority Board of Directors' Decision No. (25) of 2016:

"Chapter two: Obligations of the Insurance Company

**2.** Upon the occurrence for the value of the moof an accident, the company shall:

Replace the damaged motor vehicle in case of a total loss, unless the Insured requests the company to pay them the amount in cash. In this case, the company shall respond to the Insured's request."

Furthermore, in case of the total loss of the motor vehicle, an insurance company should pay the compensation within 15 days from the date of completion of the claim documents. If an insurance company delays settling the claim for more than 15 days from receiving the required claim documents, without providing satisfactory reasons to both the injured party and the authority, the insurance company may compensate the beneficiary for any costs incurred due to such delay. This is in accordance with the Article 7 of the Insurance Authority Board of Directors' Decision No. 25 of 2016 Pertinent to Regulation of the Unified Motor Vehicle Insurance Policies. "In case of total loss of the motor vehicle, the company shall: 1. Promptly pay the amount of compensation, as the case may be, according to the relevant policy within a period not exceeding 15 days from the date of completion of the claim documents. 2. If the company delavs settlement of the claim for more than 15 days from the date of receipt of the completed claim documents without giving convincing justi-

Policy Against Loss and fications to the injured party and the authority, the company shall compensate the beneficiary of the coverage stated in the insurance policy for any costs suffered by them as a result of deprivation from the damaged motor vehicle.

> 3. Pay compensation tor vehicle according to the agreement between the company and the insured in the insurance policy against loss and damage.

> 4. Compensation will be made on the basis of calculation of the market value of the motor vehicle for the damage covered by the motor vehicle insurance policy against third party liability, by an expert or by setting the average value of three proposals from licensed motor vehicle showrooms in the state."

Based on the relevant provisions of law, an insurance company must settle compensation for a total loss within 15 days of receiving all required claim documents. However, since your compensation payment has been delayed for more than two months without a reasonable explanation, you may be entitled to additional compensation for any costs incurred due to this delay. To address this issue, you can begin by contacting your insurance company to request an explanation for the delay. If you are not satisfied with the response, you may approach the Insurance Authority of the UAE to seek an amicable resolution. However, if there is no amicable settlement, you have the option to take legal action by filing a case through the relevant court in the UAE that has jurisdiction to resolve the matter.

VISA ON ARRIVAL (VOA)

An Arrival Visa (a visa on arrival) is a kind of visa that is granted at the entry point of a country. A seaport, an airport, or a land checkpoint could be this. Unlike an Embassy visa, you can get a visa on arrival rather than having to apply for one beforehand. This kind of visa is the result of a bilateral agreement.

However, you must meet the requirements set by the host nation in order to be eligible for a visa upon arrival.

Why is a Visa Granted upon Arrival? For short-term travel, business meetings, family visits, medical controls, etc., a visa on arrival is usually granted.

Please note that you are not permitted to work or stay for an extended period of time or register for the various benefits offered by the national government of that country with a visa on arrival.

How Can I Get a Visa When I Arrive? You apply for a visa on arrival, as the name implies, as soon as you get to the country's port of entry. To apply for a VOA, you need to provide a list of documents specific to each country. With the necessary paperwork in hand, proceed to the Visa on Arrival area when you arrive. Certain countries will issue the visa at the checkpoint, while others will have a specific location, like a booth or counter, to receive VOA applications. You must present the necessary paperwork to the visa or immigration officer. Complete the necessary payment for your visa application. The cost of your visa may vary based on the country you intend to visit. In the event that you must pay the visa fee in cash (in the local currency), you should prepare ahead of time by having the local currency on hand. Wait until your visa is issued at the border crossing. **Required Documents for a Visa** on Arrival: Depending on the country you may be visiting, different documents may be needed. However, the following are typically included: \* A passport that is currently valid for at least a year \* Copies of your prior visas, if any, must also be included \* Passport-size photographs \* A filled-out and signed application \* Find out if you need to bring a printed copy of the application by checking the website of that country's embassy or immigration \* The visa fee can be paid with cash or a card. You must provide documentation that you have completed paying the visa application fee, if it is necessary to do so in advance. In the event that you must pay the visa fee in cash (in the local currency), you should prepare ahead of time by having the local currency on



hand \* A rental agreement or a hotel reservation to be used as accommodation proof \* A ticket for the return trip \* A current certificate of health insurance for travel \* A bank statement document from your bank issued at least in the last three months \* Note: If you do not meet the requirements and do not provide the necessary paperwork, your visa may be denied. Visa on arrival processing time can take 10 minutes to hours. The delay depends on factors such as the number of applicants, the speed of the officer at the checkpoint, whether you have met all the requirements, and the availability of the required documents.

What Is the Duration of a Visa on Arrival? The typical duration of a visa on arrival is 14–30 days. The length of a visa on arrival, however, may vary because the nations have different visa regulations. The number of days your visa has been granted will be communicated to you after your application has been approved.

Is it possible to extend a visa on arrival? Yes, you might be able visitors landing slips, which are typically not needed to depart. What advantages come with traveling without a visa? Traveling without a visa enables tourists to go whenever they want without having to plan ahead or gather paperwork. Furthermore, unlike those where obtaining a visa requires payment, these countries allow free entry. You can travel more freely because you do not have to wait for your visa to be approved. Customs and immigration procedures are typically quicker. Visa-free travel has many advantages, but visitors should not stay longer than permitted. Even those who are granted visa-free entry are only permitted to stay in a country for a set amount of time, typically 15 to 90 days, and occasionally this must be within 180 days or a year. Overstaying is considered an immigration offense that can result in criminal or civil charges as well as future travel bans. VISA PROGRAM GOLDEN

Outstanding Specialized Talents: If you have extraordinary specialized talent, you may be granted a Golden Visa for a period of ten years. Outstanding specialized talents include: \*Doctors\*Scientists\*Creative people of culture and art\*Inventors\*Executives\*Specialists in scientific fields\*Athletes\*Holders of doctorates and experts in science and engineering disciplines\*

Application Process of GOLD-EN VISA: Step 1: Choose an Investment: Choosing an investment path, such as direct investments in real estate, Public Investments, or applying to become an entrepreneur, is one of the most important steps. Step 2: Invest the Funds: Determine the necessary amount of capital investment based on the investment path selected.
