Bengaluru leads as top job hub

MUMBAI: Bengaluru dominated as the country's top city for job opportunities and salary growth as it has registered a 9.3pc year-onyear increase, closely followed by Chennai and Delhi.

This growth underlines Bengaluru's reputation as a technology and business hub as the average monthly unified salary in the city stood at Rs 29,500, making it the highest-paying city in the country, according to TeamLease

The report is based on an analysis of unified salaries across temporary and permanent hiring markets. This was closely followed by Chennai and Delhi, which reported strong salary growth of 7.5pc and 7.3pc respectively, reflecting the competitive nature of

these job markets, it noted. Chennai's average monthly salary stood at Rs 24,500 while in Delhi, it reached Rs 27,800, according to the report.

Mumbai and Ahmedabad also reported steady salary increases, reinforcing their importance as key employment centres with the financial capital of the country offering an average salary of Rs 25,100, while Pune stood at Rs 24,700, maintaining competitive pay levels. Meanwhile, the report revealed that on the industry front, retail has emerged as the top performer, with a remarkable 8.4pc salary growth. This trend was followed by consumer durables (5.2pc) and BFSI (5.1pc), both continu-

Festival buying lights up economy

MUMBAI: Key high frequency economic indicators show a latent momentum in the economy due to Diwali. While passenger vehicles retail sales surged 20pc in Oct, consumption of auto and jet fuel rose between 0.8 and nine per cent. In the same month, registration of e vehicles jumped 55pc while UPI transactions hit a new high with a growth of 45pc.

GST collection in Oct grew by nine per cent to Rs 1.87-lakh-crore. This collection is related with goods consumed and services availed in Sept. Though the collection in October was in single digit for a second successive month, it needs to be noted that the annual ritual of Shradh was observed from Sept 17.

This means that there were just 16 auspicious days in Sept for fresh purchase, especially of consumer durables which account for a large chunk of GST collection. According to industry sources, retail passenger vehicle sales for Oct would be between 4.80 and 4.90 lakh as against 3.9 lakh during the same month in 2023, showing a growth of 20pc.

Boosting green mobility, total monthly Electric Vehicle (EV) registrations (including all categories) reached an all time high with the Oct registrations recording 2.18 lakh units which marked highest themonthly volume recorded to date. This represents a significant increase from 1.6 lakh registrations in Sept 2024 and 1.4 lakh units in Oct 2023. The electric two-wheeler market set a new record with 1.39 lakh units sold in Oct, surpassing the previous peak of 1.08 lakh units in July 2024.

IPEPCIL - ADVISORY BEWARE OF UNSCRUPULOUS AGENTS FOR OVERSEAS JOBS

Seeking employment abroad can be an exiting opportunity, but it also comes with risks if the intended job-seekers go through unauthorised agencies / personnel.

Unscrupulous agents / persons may exploit these job-seekers through social media advertisements and channels, leading to financial losses, unsafe working conditions, fraudulent activities or even human trafficking. Therefore, it is crucial to stay informed and CAUTIOUS – among the overseas job aspirants. Job-seekers are advised to protect themselves by following means:

- 1) Verify credentials of the recruitment agency / persons. Ensure that, the recruitment agency / persons are licensed by the Ministry of External Affairs, OE, PROTECTOR GENERAL OF EMI-GRANTS, Government of India.
- 2) Avoid any upfront payment in case asked for.
- 3) Seek legal advice through trusted advisors or Regional Protector of Emigrants Offices.
- 4) Do not enter any dealings with lack of physical office or any credibility of the advertisers without referring their websites.
- 5) Do not deal with the unscrupulous agencies who are inconsistent or give evasive answers to your questions.
- 6) Reporting Fraud:

If you suspect that an agent / person is doing fraudulent activities related to overseas recruitment / employment, report it to the nearest POE Office, police station etc. etc; your report can help to prevent others from falling victims to scams.

Your safety and well-being are paramount, by staying vigilant and informed, you can avoid falling prey to unscrupulous agents and ensure a secure legitimate path towards overseas employment. -VS Abdulkareem (President, Indian Personnel Export Promotion Council – IPEPCIL).

If I fail to make mortgage payments, do I risk losing property, installments?

five years ago. What happens if I am unable to make the mortgage payments? Do I risk losing my house? If so, what happens to the installments I have paid already?

Pursuant to your query, it is assumed that you are an expatriate owning a property in Dubai. Therefore, the provisions of Law No. 14 of 2008 Concerning Mortgage in the Emirate of Dubai and the provisions of Federal Law No. (5) of 1985 On the Civil Transactions Law of the UAE are applicable.

If a mortgagor (borrower) defaults in repaying a mortgage loan to a mortgagee (lender), the lender may commence the sale of a mortgaged property upon serving a 30-day notice through a Notary Public to a mortgagor. This is in accordance with Article 25 the payment of a debt or upon fulfilment of a condition under which early repayment of debt is required the creditor-Mortgagee or his universal or particular successor may foreclosure commence and forced sale procedures against the mortgaged real property provided that the debtor or the person who has possession of the mortgaged real property or real property unit is served at least a 30-day notice through a Notary Public."

Thereafter, upon service of notice through a Notary Public by a mortgagee (lender) to a mortgagor (borrower), mortgagee may file an execution case based on a mortgage deed and agreements signed between a mortgagor (borrower) and a mortgagee (lender) in a court which

This is in accordance with Article 26 of the Dubai Mortgage Law, which states: "If a debtor-mortgagor, of the Dubai Mortgage his universal or particular Law, which states: "In successor or a real surety Law are read with Arti the event of default in fails to pay the debt within the period stipulated in the preceding Article (Article 25 of Dubai Mortgage Law), the enforcement judge shall, upon request of the creditor-mortgagee, issue an attachment order against the mortgaged real property in order to sell it by public auction in accordance with the applicable procedures of the Dubai Land Department."

> However, an enforcement judge on a request of a mortgagor (borrower) may postpone the auction of property for a period of 60 days if the judge is satisfied that a mortgagor (borrower) can repay the balance mortgage loan within the said 60 days or if the auction of the property may cause substantial damage to a mortgagor (borrower). This is in accordance with Article 27 of the Dubai Mortgage Law.

Further, in the event a mortgagor (borrower) does in an auction conducted by the concerned auctioning authority within the grace period. This is under Article 28 of the Dubai Mortgage Law.

It should be noted that all the aforementioned provisions of Dubai Mortgage cle 1430 of the UAE Civil Transactions Law, which states:

"A mortgagee may, upon maturity of the debt, take proceedings for the expropriation of the mortgaged property and the sale thereof, in case the debt is not paid on its due date, after notification of the debtor and the possessor of the property in accordance with the procedures set forth in the Law on procedures to be followed before the civil court-2 and the special laws."

Based on the aforementioned provisions of Dubai Mortgage Law and UAE Civil Transactions Law, if you as a mortgagor (borrower) fail to repay the mortgage loan to the mortgagee (lender), then the mortgagee (lender) may file an execution case before an execution judge in the Dubai Court to sell your mortgaged property through a public auction

to the Dubai Court's bank account within stipulated days. However, it is assumed that you have availed long-term mortgage loan from the mortgagee (lender) and as you property

Therefore, in such a scenario if your mortgaged property is sold in a public auction, the bank may only be entitled to the outstanding amount of the mortgage loan, penalties whatsoever as agreed in the mortgage deed or agreement with you, court fees, auction fees, interests, and any other fees/costs if any. Thereafter, Dubai Court upon settling your bank's (mortgagee) outstanding amount as per the execution order, may transfer to your bank account if any residual amount is remaining from the sale proceeds of the auction of your mortgaged

Lufthansa, Singapore Airlines eye flights to Noida airport

NOIDA: Noida International Airport (NIA) is poised to become a key global hub in aviation and will offer international routes to Zurich (ZRH), (SIN) Singapore and Dubai (DXB), operated by Lufthansa (LH), Singapore Airlines (SQ), and other international carriers enhancing global connectivity for India.

In addition to these international links, NIA will serve 25 domestic routes connecting major cities, positioning Noida as an essential travel hub.

Noida Airport (DXN) in Jewar, western UP, will initiate the second phase of its trial operations on Nov 15, a critical step towards its official launch. This trial phase, running until Dec 15, will feature daily flights from Akasa Air (QP), IndiGo (6E), and likely Air India (AI), as confirmed by Arun Veer

Singh, CEO of Noida International Airport.

"The testing process will continue for one month. We will upload the data to the DGCA website on Dec 20 and then apply for aerodrome licensing," Singh stated.

The Directorate General of Civil Aviation (DGCA) will evaluate this data to determine the airport's readiness for full operations, with hopes of obtaining the necessary licensing by March 20, 2025.If all goes according to plan, Noida International Airport will begin commercial operations on April 17, 2025. On its opening day, the airport expects to handle 30 flights, including 25 domestic flights, three international flights, and two cargo flights.

Everything You Must Know About Passports

White Passport (S-type passport): A white passport is a type of passport granted to Indian government officials travelling overseas for official work. The S-type passport is another name for it. White passports are usually issued to senior government officials, members of administrative services, high-ranking officials, and diplomats, members of the Indian Foreign Service, and IAS and IPS officers. Immigration officers can identify Indian diplomats and officials with the use of white passports. During immigration checks, they also enable passport holders to be given preferential treatment.

Maroon Passport (D-type passport): TheMaroon passports are diplomatic passports granted to high-ranking government officials and diplomats in India. The Maroon passport (the passport color in India for diplomatic passports is maroon) is a diplomatic passport. The major benefits of a Maroon passport are diplomatic immunity, easier immigration, legal protection and so on.

The Maroon passport is issued to Indian diplomats, Members of Parliament, Union Council of Ministers and government officials with high-ranking diplomatic status, Indian Police Services (IPS), Indian Administrative Services (IAS), and Indian Foreign Services (IFS). High-ranking Indian state officials may also apply for and request a diplomatic passport while on official business.

Online or e-Passports: An electronic passport, or E-passport, is one that has a chip that holds all of the holder's biometric data. As a result, this procedure speeds up immigration checks while enhancing the security and transparency of travel documents.Because it can be scanned, travelers can avoid standing in line

Recently, in 2024, the Ministry of External Affairs (MEA) of India announced new passport make the application process easier for you.

The following is a list of the main changes that are currently in place as well as some that will soon be implemented:

1. There will be no residential information on the last page of the passport.

According to the new Indian passport rules, your residential address will no longer be printed on the final page of your passport in order to protect your personal information. By scanning the barcode on the passport, the immigration officials can obtain the passport holder's information.

2. The new passport color codes

ly Orange): ECR (Emigration Check Required) & ECNR (Emigration Check Not Required). This color distinction makes it simple to identify the type of passport holder.

3. No parent names appear on the passport.

Your parents' names will no longer appear on the last page of the passport for privacy reasons. Children of single parents or those from estranged families particularly benefit from this rule. Parents are expected to clarify the status when submitting an application.

4. Online Police Verification

The new passport rules in India allow for an on-

verification line cess through the Crime and Criminal Tracking Network and Systems (CCTNS) in collaboration with the MEA, which will replace the traditional police verification system. This saves time by making the verification process faster and more effective.

5. Substitutes for Birth **Certificate:**

If you're applying for a passport, the following documents may be submitted in lieu of a birth certificate in accordance with the new regulations. These include: Aadhaar card, voter ID, PAN card, driving license, school leaving certificate, matriculation certificate, or transfer certificate, life insurance policy with birth date, and name of one of the parents or legal guardians. For many applicants, this flexibility facilitates a more seamless application process.

6. Reduced Annexes:

By eliminating multiple annexes, the new passport rules have simplified the paperwork. Since annexes are self-declaration forms, attestation is no longer required. To cut down on processing time, Annexes A, C, D, E, J, and K have been eliminated, and some have been combined.

7. Married and divorced individuals:

Since Annexure K has been eliminated in accordance with the new passport rules, neither a marriage certificate nor the spouse's name is needed. This change makes passport application processes easier for people who are married or divorced.

8. Urgent Passports for **Jobs:**

If government workers cannot obtain an identity certificate or No Objection Certificate (NOC) from $ext{their}$ employers, they may submit a self-declaration form for an urgent passport. The issuance process will proceed more quickly as a result.
